CHEMICAL FACILITY ANTI-TERRORISM STANDARDS
PRIVACY ACT NOTICE

The Department of Homeland Security (DHS) requires the Michigan Operations facility to comply with Chemical Facility Anti-Terrorism Standards (CFATS) Personnel Surety Program requirement to identify affected individuals with terrorist ties. Affected individuals include employees and contractors who have, or who are seeking access, anywhere inside the protected perimeter of the Michigan Operations facility. DHS conducts CFATS Personnel Surety Program activities pursuant to section 2102 of the Homeland Security Act of 2002 and 6 CFR § 27.230(a)(12)(iv).

Michigan Operations has opted to comply with this requirement by **either (1)** collecting and submitting the Personally Identifiable Information (PII) of affected individuals to DHS for the purpose of comparing that PII against information pertaining to known and suspected terrorists maintained by the Federal Government in the Terrorist Screening Database (TSDB) **or (2)** confirming your enrollment in a federal screening program by verifying one of the following federal screening program credentials, if applicable: Hazardous Materials Endorsement (HME) on a State-Issued Commercial Driver's License, Transportation Worker Identification Credential (TWIC), Global Entry Card, or a U.S. Customs and Border Protection NEXUS or SENTRI card. Affected individuals will undergo recurrent vetting against the TSDB.

If you possess an applicable federal screening program credential and it is successfully verified, then no information about you will be submitted to DHS under the CFATS Personnel Surety Program. If you do not possess a federal screening program credential, or if your federal screening program credential cannot be successfully verified, then Michigan Operations may need to conduct additional screening to comply with the CFATS personnel surety requirements. This may include submitting information to DHS. Michigan Operations is not required to submit this information to DHS more than one time. However, in certain cases, DHS may request that Michigan Operations collect and submit additional information about affected individuals in order to clarify data errors or to resolve potential matches (e.g., in a situation in which an affected individual has a common name, additional information could assist DHS in distinguishing that individual from known or suspected terrorists with similar names). Such requests will not imply, and should not be construed to indicate, that an individual has been confirmed as a match to the TSDB.

DHS may share information provided by Michigan Operations, and its designees, if applicable, about you with law enforcement or intelligence agencies under its Privacy Act System of Records Notice published in the *Federal Register*. To view this System of Records Notice (Department of Homeland Security/National Protection and Programs Directorate-002 Chemical Facility Anti-Terrorism Standards Personnel Surety Program System of Records) and for more information on DHS privacy policies, please visit the DHS Privacy Office website at <http://www.dhs.gov/privacy>. DHS may also share your information and information about you with Michigan Operations, or its designees, if applicable. DHS will not make available certain information about you that was not supplied by Michigan Operations, or its designees.

If you would like access to the information provided by Michigan Operations, or its designees, about you, please contact your supervisor. If your information contains errors, you should inform Michigan Operations.

If Michigan Operations, or its designees, is either unable or unwilling to update or correct your information, you may also write to the NPPD Freedom of Information Act (FOIA) Officer at 245 Murray Lane SW, Washington, D.C. 20528-0380 to obtain access to your information, and if necessary, to correct inaccurate or erroneous information. REDRESS:

If you believe that the information submitted by Michigan Operations, or its designees, has been improperly matched by DHS to the identity of a known or suspected terrorist, you may write to the NPPD FOIA Officer at 245 Murray Lane SW, Washington, D.C. 20528-0380. You may also request an administrative adjudication under CFATS pursuant to 6 CFR § 27.310(a)(1).

You may inspect STERLING’s files concerning you during normal business hours and upon reasonable notice. You can inspect the files at STERLING’s offices if you furnish proper identification, and you can obtain a copy by paying duplication costs. One other person can accompany you if he or she furnishes reasonable identification. You can also obtain a copy of your files by sending STERLING at the address listed above a written request, including proper identification, by certified mail. STERLING will give you a summary of the information in the files by telephone if you submit a written request including proper identification. STERLING has trained personnel who can explain the information furnished to you and can provide a written explanation of any coded information contained in your files. “Proper identification” includes documents such as a valid driver’s license, Social Security card, military identification card or credit card. If necessary, STERLING may request additional information about your employment and personal or family history to verify your identity.

A Summary of Your Rights under the Fair Credit Reporting Act

The federal Fair Credit Reporting Act (FCRA) promotes the accuracy, fairness, and privacy of information in the files of consumer reporting agencies. There are many types of consumer reporting agencies, including credit bureaus and specialty agencies (such as agencies that sell information about check writing histories, medical records, and rental history records). Here is a summary of your major rights under the FCRA. **For more information, including information about additional rights, go to www.consumerfinance.gov/learnmore or write to: Consumer Financial Protection Bureau, 1700 G Street N.W., Washington, DC 20552.**

You must be told if information in your file has been used against you. Anyone who uses a credit report or another type of consumer report to deny your application for credit, insurance, or employment – or to take another adverse action against you – must tell you, and must give you the name, address, and phone number of the agency that provided the information.

You have the right to know what is in your file. You may request and obtain all the information about you in the files of a consumer reporting agency (your “file disclosure”).

You will be required to provide proper identification, which may include your Social Security number. In many cases, the disclosure will be free. You are entitled to a free file disclosure if:

- a person has taken adverse action against you because of information in your credit report;
- you are the victim of identity theft and place a fraud alert in your file;
- your file contains inaccurate information as a result of fraud;
- you are on public assistance;
- you are unemployed but expect to apply for employment within 60 days.

In addition, all consumers are entitled to one free disclosure every 12 months upon request from each nationwide credit bureau and from nationwide specialty consumer reporting agencies. See www.consumerfinance.gov/learnmore for additional information.

You have the right to ask for a credit score. Credit scores are numerical summaries of your credit-worthiness based on information from credit bureaus. You may request a credit score from consumer reporting agencies that create scores or distribute scores used in residential real property loans, but you will have to pay for it. In some mortgage transactions, you will receive credit score information for free from the mortgage lender.

You have the right to dispute incomplete or inaccurate information. If you identify information in your file that is incomplete or inaccurate, and report it to the consumer reporting agency, the agency must investigate unless your dispute is frivolous. See www.consumerfinance.gov/learnmore for an explanation of dispute procedures.

Consumer reporting agencies must correct or delete inaccurate, incomplete, or unverifiable information. Inaccurate, incomplete or unverifiable information must be removed or corrected, usually within 30 days. However, a consumer reporting agency may continue to report information it has verified as accurate.

Consumer reporting agencies may not report outdated negative information. In most cases, a consumer reporting agency may not report negative information that is more than seven years old, or bankruptcies that are more than 10 years old.

Access to your file is limited. A consumer reporting agency may provide information about you only to people with a valid need -- usually to consider an application with a creditor, insurer, employer, landlord, or other business. The FCRA specifies those with a valid need for access.

You must give your consent for reports to be provided to employers. A consumer reporting agency may not give out information about you to your employer, or a potential employer, without your written consent given to the employer. Written consent generally is not required in the trucking industry. For more information, go to www.consumerfinance.gov/learnmore.

You may limit “prescreened” offers of credit and insurance you get based on information in your credit report. Unsolicited “prescreened” offers for credit and insurance must include a toll-free phone number you can call if you choose to remove your name and address from the lists these offers are based on. You may opt out with the nationwide credit bureaus at 1-888-5-OPTOUT (1-888-567-8688).

You may seek damages from violators. If a consumer reporting agency, or, in some cases, a user of consumer reports or a furnisher of information to a consumer reporting agency violates the FCRA, you may be able to sue in state or federal court.

Identity theft victims and active duty military personnel have additional rights. For more information, visit www.consumerfinance.gov/learnmore.

States may enforce the FCRA, and many states have their own consumer reporting laws. In some cases, you may have more rights under state law.
